## State compensation I

 Compensation for victims of violence are defined by the Crime Vicitms Compensation Act (OEG)

Who will get compensation?

Only when the victim is attacked physically

What are the requirements?

> No victims' participation in the crime

Victims should (not obligatory in every case) report the offence to the authorities

 The benefits are defined in the social compensation law BVG (Bundesversorgungsgesetz)

It was developed after the WW II

Victims get compensation like soldiers

## State compensation II

- Victims have to apply for compensation
- The special office will clarify the circumstances of the crime and the physical and psychological injuries
- Compensation will be granted as long as the physical or psychological injury will persist
- Compensation for pain and personal suffering will not be paid

## **State Compensation III**

- In many cases: long procedures
   Difficulties in evidence
  - Difficult matters
- Land of Bavaria

Two special offices dealing with serious acts of crime

>fully qualified lawyers decide

>they have a lot of experience

Supervisors – visiting the victim

## **Medical Treatment**

- Medical Treatment is given by healthy insurence, but
  - there is no additional payment after acceptation of the case, as
    - ➢ for stay in hospital
    - ≻ for medication
    - Travel expenses to psychological therapy
  - Therapy is not limited to the rules of the public insurance (such as psychological therapy)
- Psychological help in "Trauma Ambulances"

## Trauma Ambulances II

• <u>Settlement:</u>

Agreement of supply management and trauma clinics

- ♦ 5-10 therapy sessions
- Exceptional case possible up to 15 sessions
- OEG Application with help by trauma clinic
- <u>Bavaria:</u>
  - Possibility of assistance to law enforcement department or process
    - (prior information/permission of the office ZBFS required)

## Trauma Ambulances III

- Awareness of the German Institute for Psychotraumatology Cologne
- Assistance within 3 months after the crime

>92 clients, 27 % under 5 hours

≻48 % up to 5 hours

≻5 % under 10 hours

>9 % up to 10 hours and no need of further therapy sessions

## **Disability Pension**

- Degree of injury consequences (Grad der Schädigungsfolgen) as a result of the crime is at least 25 for more than 6 months
  - Monthly pension, depending on the degree

≻ GdS 30 = 127 €

>GdS 50 = 233 €

It isn't allowed, to take this pension into account to other benefits of the state

- If there is loss of earnings, there are pensions, depending on the income
- Payments for widows, orphans and parents

## **Compensation for Foreigners**

- Eu-inhabitants and some other groups of foreigners get the same compensation as german inhabitats
- For others special eligibility criterias are valid like
   Duration of the planed abidance: if more than 6 months planed, they can get medical treatment and some kinds of pension
   Relationship to the person they visit
   Settlement of hardship cases

## Act of violence abroad

 Since 1. Juli 2009, victims have the right to state compensation (OEG), when the act of violence happened abroad, but

Sonly medical treatment

no pension, but only a singular payment, depending on the Degree of injury consequences, at least GdS 10

a single payment for widows, orphans and parents

Regress

- If the victim has applyed for state compensation (pursuant Crime Vicitms Compensation Act -OEG), the state will reclaim it from the perpetrator - but
- the state is allowed to waive a claim, if there is a danger for the victim
- the Federal Ministry of Labour and Social Affairs confirmed this in a ministerial circular

## Adhesive procedure

- Victims are able to claim for compensation within the criminal trial
  - The judge has to decide, when victim applies for Compensation for pain and suffering
     He is free not to decide, when victim applies for compensation for damages

# Compensation of vicitms of extremist attacks

- Voluntary payment act of solidarity
   One-off capital payments
  - Hardship compensation for physical injuries or for pain and suffering
  - Maintenance payment damages and for disadvantages in career progress
  - No compensation for material damages
  - Vicitms includes close relatives and so-called helpers in need
