# What did Victim Support Netherlands (VSN) do?

- Providing safety, fulfilling basic needs
- Legal and practical support
- Referral to other organisations

### **VSN: Basic principles**

Support is offered mainly by trained volunteers, following two basic principles:

- Watchful waiting
- Stepped care





#### **VSN:** Target groups

- Victims of human-afflicted crime
- Victims of traffic accidents
- Victims of other calamities (airplane disaster Tripoli, train collision Amsterdam, shopping mall shooting Alphen)




### **VSN:** Sources of support

- Practical
  - Contacting family or friends
- Emotional
  - Listening, providing attention
- Legal
  - Accompanying people to court, giving information about the court setting

### Systematic scientific evidence

There is a need for systematic evidence supporting the current services of Victim Support Netherlands:

- To detect strong points
- To detect possible niches in current services



# Collaboration VSN & Utrecht University

A multidisciplinary team was formed to map the existing qualitative and quantitative evidence:

- Four methodologists of Utrecht University
- One senior policy maker of Victim Support Netherlands
- One full professor in Victimology affiliated with Tilburg University

### **Project description (1)**

- Two systematic reviews
  - A qualitative evidence synthesis

To assess which responses from non-professionals (e.g. the social network, volunteers) are experienced as supportive by victims of human-afflicted crime.

## **Project description (1)**

- Two systematic reviews
  - A qualitative evidence synthesis

- A meta-analysis

To gain insight in empirical evidence for non-professional interventions aimed at these victims.

## **Project description (2)**

#### Results of both reviews will be combined to:

- reveal whether the needs of victims are in line with existing interventions.
- trace possible niches in current interventions.

This combination of different reviews as a method is developed at the Evidence for Policy and Practice Information and Co-ordinating Centre (EPPI) in London.



### **Project description (3)**

Advantages of combining different types of evidence:

- Integration of different types of findings;
- Comparison of findings with the practices of Victim Support Netherlands

## **Project description (4)**

Possible weakness of the method:

 Findings can be too general for the specific context of Victim Support Netherlands

Therefore, we aim to move from a multicontext review into a context-specific review

#### Scientific outcomes

- A qualitative evidence synthesis giving an overview of the needs of victims of human-afflicted crime, accidents and other calamities.
- A meta-analysis resulting in measures of effectiveness for different interventions aimed at these groups of victims.
- A context-specific review giving an overview of evidence directly related to the practices of Victim Support Netherlands (e.g. reviewing grey literature, such as policy reports)

#### **Practical outcomes**

 A toolkit with guidelines which can be implemented in daily practice, to further improve the support services of Victim Support Netherlands.




