# Three different ways for crime victims to receive compensation

- Damages paid by the offender
- Insurance compensation
- Criminal injuries compensation



#### **Children Witnessing Violence - Prevalence**

- 10 % of children have experience of violence in their home, 5 % often
- About 200 000 children in Sweden have experience of violence in close relationships



Children as witnesses or victims of mental assault?

- Mental assault is not prosecuted in Sweden
- The official inquiry SOU 2001:72 "Child Abuse" did not change this:
  - Children witnessing violence were deserted by the criminal law
  - but could be a basis for a more severe penalty for the crime: "if a child is thereby deprived of his or her security", from July 2003



The witnessing child shall be looked upon as a victim of crime:

 in the social welfare system, and
is given the right to a special form of criminal injuries compensation from the state


Governmental Bill (2005/06:166) "Children who have witnessed violence"



#### **Criminal injuries Compensation Act 4 a § since 2006**


- State compensation can be awarded to children who has witnessed crimes that can be assumed to harm the child's confidence and trust in a person with whom he or she has a close relationship.
- The government has a responsibility to compensate children who have witnessed criminal acts towards persons close to them, even though the child cannot claim damages from the offender.

#### Prerequisites

- Judgement convicting the perpetrator for the witnessed crime
- Child→ below the age of 18 yrs at the time of the crime
- Witnessed  $\rightarrow$  seen or heard the crime
- Close relationships → biological parents, foster parents, grandparents etc.



• Which crimes?

 $\rightarrow$  Any physical and sexual violence, unlawful threats, wrecking the apartment or house in front of the child

#### Assessment

 $\rightarrow$  The injury, mortification and danger that the crime typically can be assumed to inflict on children

#### • Amount?

 $\rightarrow$  The severity of the crime witnessed



#### EXAMPLES

- 5 000 SEK Pysical abuse, one occasion
- **10 000 SEK** Physical abuse and unlawful threats, several occasions
- 15 000 SEK Physical assault with deadly weapon
- **20 000 SEK** Severe physical violence and threats with deadly wepons on numerous occasions during two years
- 25 000 SEK Sexual assaults during five years

**40 000 SEK** Severe physical and sexual violence during several years

#### **Practical challenges**

- Evidence of the original crime
- Evidence of the child witnessing the crime

The child is often neglected by police and prosecutor

• Joint custody

Both custodians have to sign the application for compensation

• E-learning tool for police officers and prosecutors



Year	Applications	Decision	Appoved applications	Average compensation
2012	253	238	68 % (162)	7 200 SEK
2011	239	234	69 % (162)	8 600 SEK
2010	223	222	53 % (118)	7 700 SEK
2009	235	266	59 % (157)	7 800 SEK
2008	275	269	49 % (132)	7 100 SEK
2007	235	187	43 % (80)	6 700 SEK <sup>4</sup>
