# Funding programmes 2007-2013

- Criminal Justice Programme (JPEN)
- Daphne III Programme: victims of violence (women, children, young people)
- Progress Programme: victims of violence (women)
- Prevention of and Fight against Crime (ISEC): victims of trafficking, sexual exploitation

# Funding programmes 2014-2020

- Justice Programme: criminal justice, including rights of victims (UK opt-out)
- Rights, Equality and Citizenship Programme: victims of violence (women, children, young people, other groups at risk in close relationships)
- Internal Security Fund: Police cooperation and preventing and combating crime

# Funding instruments

1. **Action grants** – funding for transnational projects
2. **Operating grant** – operating costs for EU level NGOs and similar bodies
3. **Procurement** – service contract tenders (EU studies, EU conferences, EU campaigns etc.)

## Implementation of funding programmes

- Annual Work Programmes
- Call for proposals
- Submission of applications
- Evaluation of applications
- Award decision
- Notification of applicants, budget reviews
- Signature of grant agreement
- Final report

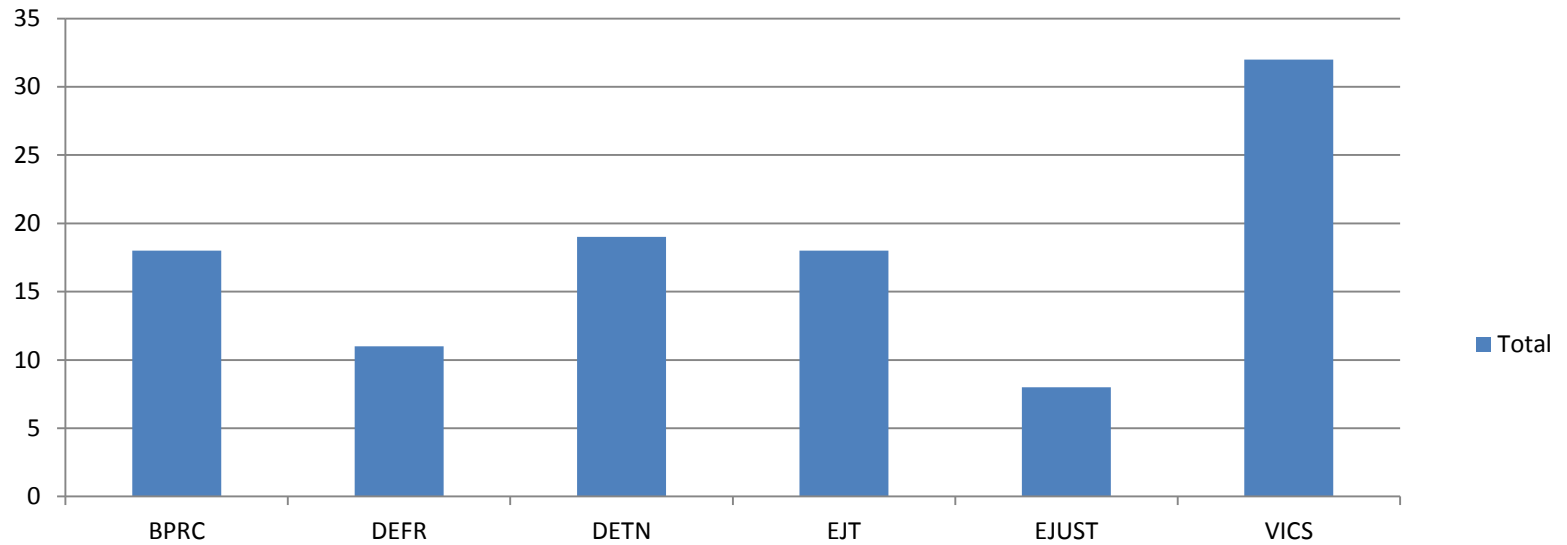

- ✓ **Strong EU dimension, EU added value**
- ✓ **Sustainable results, good dissemination**
- ✓ **Good value for money, well planned budget**

## JPEN AG Call 2012: number of applications by priority

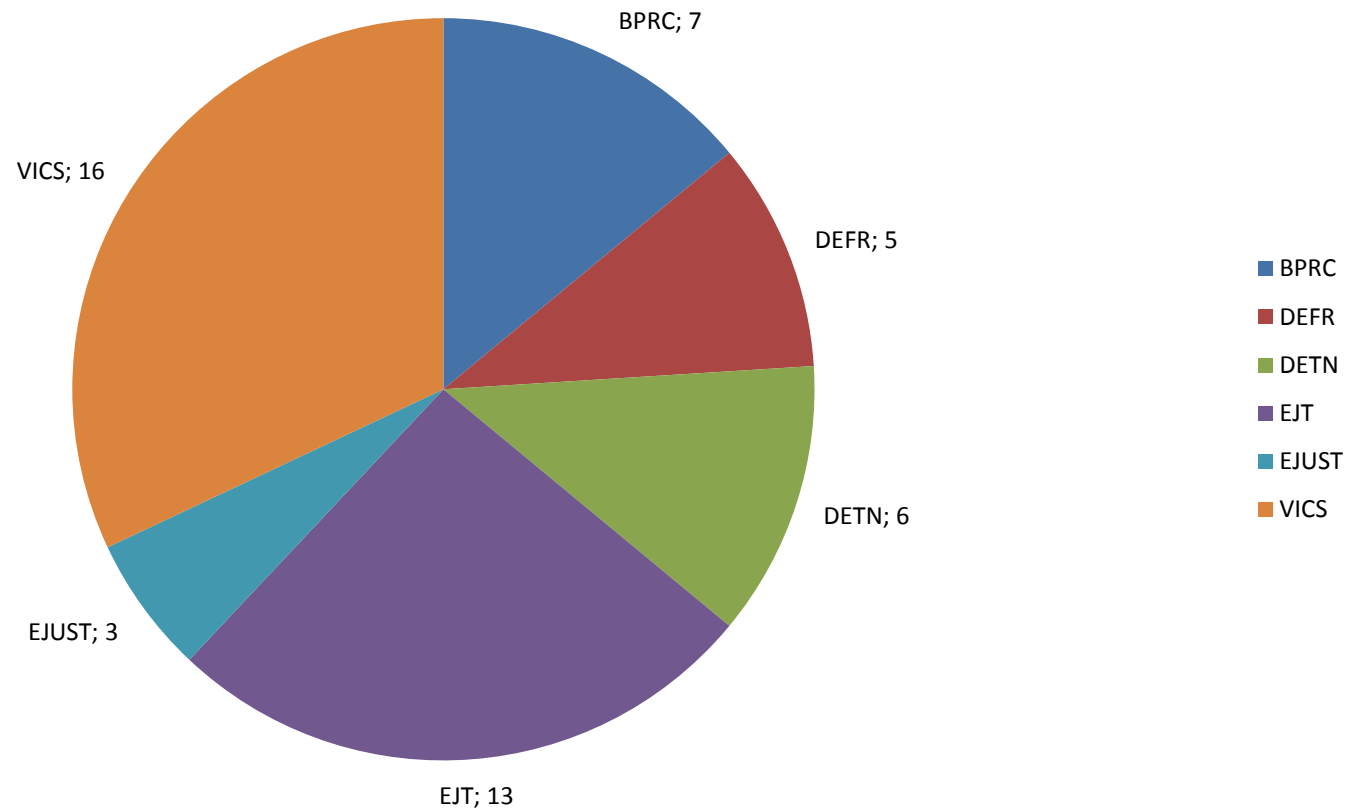

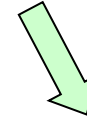
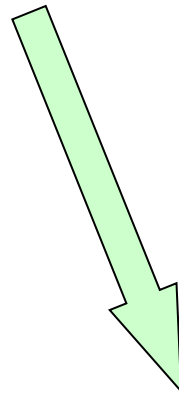
